SHDC PLANNING DECISIONS SINCE THE LAST MEETING:

PARISH PLAN PRIORITIES

1. Increase in parking space - *Ongoing, dependant on housing development*
2. Improve communications throughout the Parish - *automatic e-mailing of forthcoming events*
3. Speed of traffic through Fore Street, *Speedwatch and traffic calming*
4. Maintain improvement to Timbers - more space for cars reducing/deleting boat park spaces -improve mooring spaces on estuary
5. Pedestrian and cycle path to Bridge End
6. Wind/energy generation project *Only viable with a commercial partner*
7. Sustainability of Parish - shop, affordable housing, school, church
8. Increased social events and concerts, community events etc
9. More activities aimed at younger people to gain interest and involvement.
10. Creation of informal cycle track/route
