**1. TYPES OF COMPLAINT**

A complaint is a formal accusation and councils should be prepared to deal with three classes of complaints:

**1.1** The clerk should be dealt with as an employment matter. The complainant can be assured that the matter will be dealt with internally as such and appropriate action taken as required.

**1.2 Councillors** – these are dealt with by the Standards Board. Complainants should be advised to contact South Hams District Council Monitoring Officer for further information.

**2. COMPLAINTS ABOUT COUNCIL DECISIONS**

**2.1 Before the Meeting**

2.1.1 The complainant should be asked to put the complaint about the council's procedures or administration in writing to the clerk;

2.1.2 If the complainant does not wish to put the complaint to the clerk or other proper officer, they may be advised to put it to the chairman of the council;

2.1.3 The clerk shall acknowledge the receipt of the complaint and advise the complainant when the matter will be considered by the council or by the committee established for the purpose of hearing complaints;

2.1.3 The complainant shall be invited to attend the relevant meeting and bring with them such representative as they wish;

2.1.5 Seven clear days prior to the meeting, the complainant shall provide the council with copies of any documentation or other evidence, which they wish to refer to at the meeting. The council shall similarly provide the complainant with copies of any documentation upon which they wish to rely at the meeting.

**2.2 At the Meeting**

2.2.1 The council should consider whether the circumstances of the meeting warrant the exclusion of the public and the press. Any decisions on a complaint shall be announced at the council meeting in public;

2.2.2 Chairman to introduce everyone;

2.2.3 Chairman to explain procedure;

2.2.4 Complainant (or representative) to outline grounds for complaint;

- 2.2.5 Members to ask any question of the complainant;
- 2.2.6 If relevant, clerk or other proper officer to explain the council's position;
- 2.2.7 Members to ask any question of the clerk or other proper officer;
- 2.2.8 Clerk and complainant to be offered opportunity of last word (in this order);
- 2.2.9 Clerk and complainant to be asked to leave room while Members decide whether or not the grounds for the complaint have been made. (If a point of clarification is necessary, both parties to be invited back);
- 2.2.10 Clerk and complainant return to hear decision, or to be advised when decision will be made.

**2.3 After the Meeting**

Decision confirmed in writing within seven working days together with details of any action to be taken.
